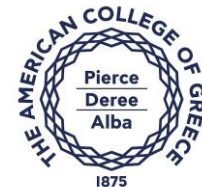

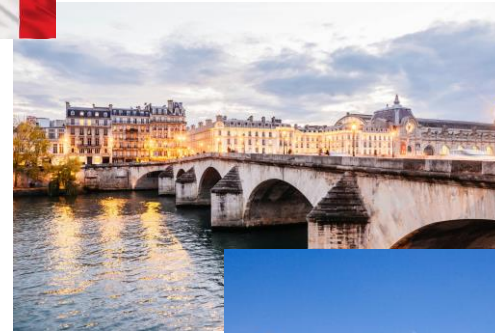

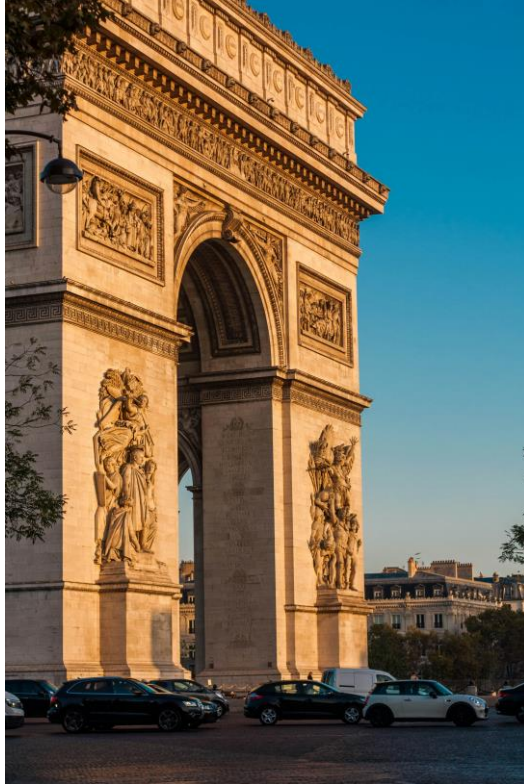

Application Process

The International Study Tours have limited places.

Your Programme Director will review all applications and allocate places to each destination.

Application criteria is announced at Induction Week when the applications open.

Dates

Dates are confirmed at Induction Week once they have been agreed with partner institutions over the summer period.

It is important to research the dates once they are announced, to ensure they don't clash with any other events or commitments.

Once you confirm you are available, you can apply to join the module.

Fees

- Once your application is **approved**, you will be required to pay a fee of **£250**.
- This fee contributes to the cost of:
 - Accommodation - shared (with breakfast)
 - Cultural activities
 - International company visits
 - Transport to/from visits
 - Welcome Dinner
 - Durham University standard travel insurance

What is NOT included

- **Travel** to/from destination
- Ensuring you comply with **visa/travel permit** requirements
- **Visa applications**
- Additional **travel insurance** (e.g. for medical condition)
- **Meals** not stated in the itinerary (e.g. lunches and dinners)
- Incidental **expenses**
