Student records deadlines

New student registration (late entrants)

The deadline for TEIs to submit new student registration data (for **late entrants**) is **2nd April 2018**.

To submit your student data, please download the <u>template spreadsheet</u> and complete the fields for each student. TEIs should email the completed spreadsheet to the Common Awards Team (common.awards@durham.ac.uk) via an **encrypted or password-protected** file.

Campus cards (late entrants)

Following the registration process for late entrants, the next campus card production will take place in May 2018. The deadline for TEIs to submit student photographs for campus cards is **4 May 2018**. Campus cards can be produced only after student records have been created in Banner, and student Banner IDs have been generated. The photographs must be submitted to the University with the student's Banner ID saved as the file name. Please also ensure that the photos provided are in the dimensions requested.

Module registration and APL

The deadline for TEIs to submit data relating to module registration and APL credits is **27th April 2018**. TEIs are asked to submit data for **all** Common Awards students (including late entrants) by this date.

To submit your student data, please download the <u>Module Registration template</u> <u>spreadsheet</u> and complete the fields for each student.

To submit your credits data relating to **approved** APL requests complete the APL template spreadsheet.

TEIs should then email the data to the Common Awards Team (common.awards@durham.ac.uk) via an **encrypted or password-protected** file. Further information is available on the <u>Module registration web page</u> and the <u>APL registration page</u>.

Invoices

Thank you to all TEIs who reviewed the census data and informed us of any remaining errors in the records. We will be sending invoices to TEIs on **1st March 2018**. The invoices will be based on a snapshot of student records data from 1st December; all changes communicated to us before 1st December will have been reflected in the invoices.

Curriculum development deadlines

TEI Programme Changes

31st May 2018: deadline for proposals from a TEI to make any changes its programme regulations (including, but not limited to: deleting a module, adding a module, restructuring module lists, and rewording the rubrics within the programme regulations. Please note that the Common Awards Team will share with TEIs a word version of their most recently approved programme regulations and request that any changes be highlighted on these versions. These will be circulated on **Tuesday 1**st May but please do contact the team if you require these any earlier.

TEI Module Changes

31st May 2018: deadline for TEIs to submit Module Overview Tables if they have made any changes that were approved at TEI level, or if they have any changes outside of the published assessment patterns guidance which need to be approved by Durham. The updated Module Overview Tables will be published on the Common Awards website.

You can read more about the Assessment Patterns monitoring and approval process here and further guidance will be published in the TEI Handbook shortly.

GDPR Sessions

The new **General Data Protection Regulation** (GDPR) will come into effect on 25th May 2018. In anticipation of this we are looking to host a number of online interactive sessions via The Hub to provide TEIs with information. The sessions will be hosted by the Common Awards team at Durham and the Ministry Division with contributions from the Queen's Foundation.

These two sessions will be the same, but offered twice to allow colleagues to attend and ask questions.

These two sessions will be the same, but offered twice to allow colleagues to attend and ask questions.

All sessions will be recorded. The sessions are designed to be interactive and will allow participants to ask questions. We anticipate that the GDPR seminars will be of most use for teaching and professional support staff with particular responsibility for student data. Further information will be circulated in advance of the sessions; however we wanted to confirm the dates in colleagues' diaries as soon as possible. The sessions will be held via The Hub. New APL Guidance

Following a period of consultation with TEIs new APL guidance has been approved by the Common Awards Management Board for 2018/19 entry. The new guidance provides a clear description on how to handle modules that are not formally part of the Common Awards suite, and should help to clarify the APL process in general. It also includes a new APL application form for 2018/19 entry and quick guides for applicants and TEI staff.

Upcoming consultations

The Common Awards team will shortly be inviting TEIs to participate in a number of consultations running this term.

We would like to remind members of TEIs that they are also welcome to contribute to the <u>rolling consultation on the TEI Handbook</u> at any point. We would welcome your feedback to help us make sure that the *Handbook* provides the information you need, in the format that is helpful.

Modules at other TEIs

At the meeting of the Common Awards Management Board on 30th January 2018, the Board approved a new process for the consideration and confirmation of module marks for those studied at TEIs alternate to the TEIs students are registered with (the 'home' TEI).

Where a student's programme under a TEI board's authority includes modules under the jurisdiction of another board of examiners, the 'home' TEI board is responsible for receiving the confirmed marks for those modules (once those marks have been confirmed by the other board of examiners).

The full procedure can be found in the <u>TEI Board of Examiners section of the TEI Handbook</u>, and the list of <u>TEI Board of Examiner responsibilities</u> has been updated to reflect this addition.

Given the importance of ensuring that module marks are shared between TEIs where necessary, it is essential that TEIs provide the dates of their upcoming Board of Examiners over the summer, and by 31st August at the latest.

TEI Boards of Examiners Reminders

The Common Awards Management Board was pleased to note that the TEI BoE minutes submitted to the Common Awards team provided a transparent record of the deliberations and decisions made by boards, and broadly confirmed that boards were operating effectively and in conformity with the expectations of the University.

However TEIs are asked to note the following reminders:

- that TEI Boards of Examiners cannot recommend classifications, and that this
 remains the responsibility of the overarching Board of Examiners. The <u>TEI handbook</u>
 and the TEI board of examiners <u>agenda template</u> have both been amended to clarify
 this point. Please use the updated version of the agenda template in preparation
 for your 2017-18 boards;
- that TEIs should provide the Common Awards team with their 2017-18 Board of Examiners dates if they have not done so already;
- that SACs are still being underused, despite being an important mechanism for
 mitigating the impact of illness or absence. The Common Awards team will work on
 providing TEIs with more guidance on how to identify typical SAC cases and how
 evidence is used to support claims;
- that students must be considered anonymously by the boards;
- that boards with very small memberships should ensure they have sufficient back-up options available in situations where key members are not able to attend.

Annual Self Evaluations

The Common Awards team would like to thank TEIs for the submission of their Annual Self Evaluations, and for highlighting key issues to be addressed by the Common Awards team. The team will circulate an overview of the University's ASE report to all TEIs in due course, and will contact TEIs individually to respond to any specific concerns highlighted.

As requested by TEIs, a summary of good practice examples identified within TEIs as part of their ASEs has been published on the <u>Common Awards website</u>.

Office for Students

The Common Awards team recently communicated updates on two pieces of external regulation relevant to TEIs:

Office for Students

Attached to the original email update was a summary of the new *Office for Students* (OfS) consultation published before Christmas. It outlined some of the key requirements of the new regulatory regime. The big implications are for existing universities, but **TEIs with SLC** access / Tier 4 Visas will need to engage by April 30th. The OfS was created in January, and will gradually take on its new regulatory responsibilities over the next 6 months.

Office of the Independent Adjudicator

The Office of the Independent Adjudicator (OIA) has also published a <u>new consultation</u>. This document – taking its lead from the Higher Education and Research Act (HERA) – **would require all TEIs to join the OIA scheme from next academic year** (as per definition in para. 1.1).

At present, students of TEIs with SLC access can appeal to the OIA, and any Common Awards student can appeal to the OIA (though Durham University) where they have an appeal or complaint that relates directly to the programme. The change would mean that TEI students can appeal or complain (through the TEI) to the OIA about services provided by TEIs. TEIs would need to pay an annual subscription to the OIA (likely to be £500-£1000).

Student Survey update

The 2017-18 Common Awards Student Survey will run from **Monday 31**st **April – Friday 25**th **May 2018**. These dates have been chosen as they: are after the NSS has concluded (which affects several TEIs); are before courses finish for the academic year; and provide Durham with time to analyse the survey results to feed into the mid-contract review, and TEI ASE processes.

The survey will be available to all students registered on Common Awards programmes in 2017-18 (as per the December census). The questions asked as part of the survey will be identical to those asked in the 2016-17 survey, in order for comparisons to be drawn.

The Common Awards team will shortly be contacting TEIs with more information on the 2017-18 timeline.

Student Elections

The elections for student representatives on the Common Awards Management Board are open, and will close on 28th February 2018.

There are four candidates standing this year; you can find more information on each candidate on our student election website.

Hopefully your local election processes are underway, and we look forward to receiving your election results form by the **9**th **March.** Please don't forget to rank the candidates in order of 1 (highest number of votes) to 4 (lowest number of votes). We will use a Single Transferable Vote system to identify the two candidates with the highest number of votes across all TEIs. The results of the election will be announced on **23**rd **March.**

Student Conference

This year's Common Awards Student Conference will be held at <u>St Aidan's College</u>, Durham from 16-18 July 2018.

Bookings will open on 26th March 2018.
