Aims:	To enable students to understand the problem of Christian disunity.
	To give students an in-depth introduction to major approaches to ecumenism, historical and theoretical.
	To help students reflect on the prospects and challenges for ecumenism in the contemporary church.
	To help students develop their understanding of ecclesiology.
Content:	General introduction to the problem of Christian disunity, including some outline history, and some concentration on particular issues of difference.
	Review of breadth and patterns of local ecumenical activity, drawing in part on students' own experience.
	Consideration of possible future paths for ecumenism, taking into account students' local experience.
	Overview of major national and international instruments of ecumenism and major patterns of dialogue and ecumenical relationship.
	Study of ecumenical methodology, e.g. through close examination of two or three reports and their associated processes.
	Exploration of fundamental ecclesiological principles at the heart of modern ecumenism, including examination of their relevance to students' own faith traditions.
