Aims:

To equip students with an informed understanding of church law relating to lay and ordained ministry.

To equip students with an informed understanding of the legal position

of ordained ministers in civil law.

To enable student to reflect on and develop their critical understanding

of the law of ministry and its relationship to history, doctrine, and

ecclesiology.

To enable students to undertake in-depth critical study of the law

relating to ministry and its underlying theology.

Content: This module will explore the law of ministry.

> The module may be delivered in an entirely ecumenical and comparative context; or instead, it may focus on the law of a particular tradition (e.g. the Methodist Church; or the Church of England and other Anglican churches,) alongside a comparative ecumenical

element.

Topics may include:

The historical, doctrinal, ecclesiological and juridical basis for the law

relating to ministry.

Church law relating both to the laity and to ordained ministers, including in relation to eligibility for public ministry, admission to office, the rights

and duties of office, and discipline.

Civil law which relates to ministry, including such topics as employment

status and freedom of religion.
