


Small Island Developing States / Large Ocean States


Seychelles land area = 455 km² Seychelles EEZ +>1.3 million km²



- 48 shared or overlapping boundaries
- 35 formalized by agreement
- ▶ 13 outstanding bilaterals
- ▶ 5 high seas
- 17 continental shelf beyond 200M
- Recommendations in 2017 (FSM, PNG, Sol Is); 2019 (Tonga)





Ocean Space

The 22 Pacific Island Countries and Territories manage 20% of the world's ocean in their Exclusive Economic Zones.



The number of treaties signed has increased in response to strengthened regional cooperation

Impacts of Regionalism on Pacific Maritime Boundary Delimitation

How Will This Operate?:

Policy:

Strategic Priority 1 of the Framework for a Pacific Oceanscape - Action 1(b):

'... the implications of climate change, sea-level rise ad environmental change on the highly vulnerable baselines that delimit the maritime zones of Pacific Island Countries and Territories should be addressed. This could be a united regional effort that established baselines and maritime zones so that areas could not be challenged and reduced due climate change and sea level rise.'

Advocacy:

- ILC Submission coordinated by Tuvalu state delimitation practice, laws, pronouncements
- Cross-regional SIDS alliance Antiqua and Barbuda and Tuvalu - Commission of Small Island States on Climate Change and International Law - tasked with developing and implementing fair and just global environmental norms and practices.
- Commission may also request advisory opinions from the International Tribunal for the Law of the Sea (ITLOS) on the legal responsibility of States for carbon COOPERATION emissions, marine pollution, and rising sea levels.




Resilient Boundaries for the Blue Pacific





- Changing situation in climate change and related environments





Case Study: Saint Lucia 1981-2015




French Republic / Saint 1981




