

Plus for all: If not taken as an A level, a grade 7 (or grade
 A) in Mathematics at GCSE.

Also accept Core Mathematics Qualification Grade 5 (or grade B)

- You will be allocated your college in or around May



- You can apply directly for a study abroad programme year or you can opt for the study abroad during your degree.
- Opportunities for study abroad in the past have been available in:

 - Asia (Japan, China & Hong Kong, Korea, Singapore)
 - North America (Canada, USA)
 - Australasia (Australia, New Zealand)

Placement Year

- You can **apply directly** for a Placement year or you can **opt for a Placement year during your degree**.
- Minimum 40 weeks full time professional level work
 experience
- Taken between your 2nd and 3rd year
- 20% Tuition fee
- Students source their own placements but will be supported fully in the process
- Get an assigned academic Placement Tutor
- Support with the recruitment process from Faculty

The Future



Great Employability

- In 2019 research from recruiter Robert Half found that a financial background is one of the factors for success for those that want to reach the top in Britain's biggest companies.
- A total of **52% of FTSE 100 CEOs have a background in finance**.
- The graduate prospects of Durham Finance students are extremely strong with 90% of leavers securing employment and/or going on to further study within six months of graduating. This meant we were ranked 2nd overall across the UK for Accounting and Finance based programmes in the Complete University Guide 2022.



Great Employability

- The 2019 High Fliers Survey also found that Durham was among the top ten universities most-often targeted by Britain's top graduate employers in 2018-2019. With respect to vacancies for graduates across fifteen main employment areas, 14% were in the area of Banking & Finance/Investment Banking.
- The median graduate starting salary on offer in 2022 from the UK's leading employers was £32,000 but for Investment Banking it was £50,000.
